INFORMATION SHEET DATA PROTECTION

We are obligated to protect your data processed in the course of the event and handling of the event and we also take this mandate seriously. Please take the time to read this information sheet and get a picture of why we collect your data and in what form we will process it.

First of all, we would like to inform you that we process your data for the purpose of legitimate interests of our organization or on the basis of legitimate interests of third parties (Art 6 para 1 lit f DSGVO), namely specifically for the purpose of organizing, handling and following up the event. In the course of the organization, for example, we will create a list of participants. During the event itself, personal data (including photos or videos) may also be created. The processing of data thus also serves the purpose of documentation. In addition, we would like to use the data you provide to send you information about further events.

Please note that we will only send you electronic event information if you have expressly consented to this (Art 6 para 1 lit a DSGVO). As mentioned above, photos may also be taken at the event. We would like to explicitly draw your attention to the fact that these photos may also be published on the Internet (homepages or social media). We justify the processing of your photos with our predominantly legitimate interest (Art 6 para 1 lit f DSGVO in conjunction with § 12 para 2 Z 4 DSG). However, if your legitimate interests are violated by the photograph, we will only process these photos if you expressly agree to this (Art 6 para 1 lit a DSGVO iVm § 12 para 2 Z 2 DSG). Please inform the photographer or contact us if you do not agree with the processing of your photos. If the processing of your photos is based on your consent, you can revoke this consent at any time. If the processing of your photos is based on a predominantly legitimate interest, you can object to this at any time. Please note, however, that once photos have been published on the Internet, they cannot be irretrievably deleted.

In particular, we would like to draw your attention to the fact that you can object to the processing of your data for advertising purposes at any time (right of objection according to Art 21 (4) DSGVO).

We will only store your data for as long as is necessary for those purposes for which we collected your data. In this context, it should be noted that for reasons of tax law, contracts and other documents from our contractual relationship must generally be kept for a period of seven years (§ 132 BAO).

We would also like to inform you that you have the right to request information about which of your data is processed by us at any time (see in detail Art 15 GDPR), the right to have your data corrected or deleted (see in detail Art 16 GDPR), the right to restrict the processing of your data (see in detail Art 18 GDPR), the right to object to data processing (see in detail Art 21 GDPR) and the right to data portability (see in detail Art 20 GDPR).

If, despite our obligation to process your data lawfully, there is contrary to expectations a violation of your right to lawful processing of your data, you have the right to lodge a complaint with the Austrian Data Protection Authority.

We hope that this information sheet has provided you with clarity about the form in which and the purposes for which we process your data.
